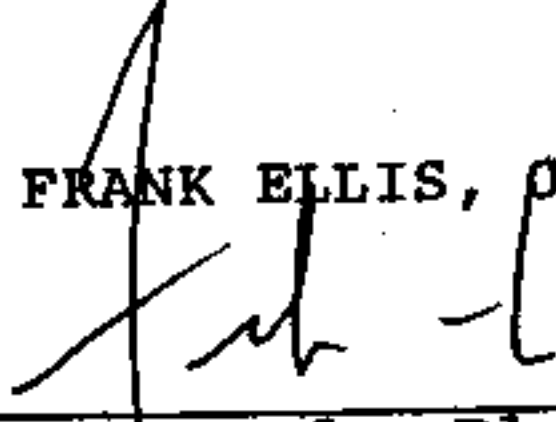

The NW $\frac{1}{4}$ of the SW $\frac{1}{4}$, Section 4, and the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$, Section 5, all in Township 22 South, Range 2 West, containing eighty acres, more or less, situated in Shelby County, Alabama.
