, 1986, the _day of<u>August</u> WHEREAS on the %th owners of the hereinafter described property filed a petition with the City Clerk of the City of Alabaster as required by Sections 11-42-20 and 11-42-21, Code of Alabama 1975, petitioning and requesting that the property hereinafter described be annexed to the municipality of the City of Alabaster, Alabama and requesting the mayor and council of said city to adopt an ordinance assenting to the annexation of said property to such municipality, which petition contained an accurate description of the property or territory proposed to be annexed together with a map of the said territory showing its relationship to the corporate limits of the City of Alabaster, and the signatures of the owners of the property or territory described were signed thereto;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF ALABASTER, ALABAMA, AS FOLLOWS:

That the City of Alabaster does adopt this ordinance assenting to the annexation of the following described property or territory to the municipality of the City of Alabaster. Said property being described as follows:

Begin at a point on the Southern boundary line of the City of Alabaster, Alabama, where said boundary intersects the Southwesterly right of way line of Shelby County Highway No. 12, in Section 23, Township 21 South, Range 3 West, Shelby County, Alabama and run Southeasterly, Southerly and Easterly along said Highway No. 12 to its intersection with the extension of the Easterly right of way line of Shelby County No. 87; thence turn left and run Northerly along said highway No. 87 to the South line of Section 29, Township 21 South, Range 2 West, then turn right and run East along the South line of said Section 29 to a point which is North 18 deg. 09 min. 44 sec. West of a point on the East line of the NE% of the NW% of Section 32, Township 21 South, Range 2 West which is 580.0 feet South of the Northeast corner of said 1-1; then turn ψ left and run North 18 deg. 09 min. 44 sec. Hollis property as described in Deed Book 332, at page 298, in the Probate Office of Shelby County, alabama; then turn right and run West along the North line of said Hollis property

and extension thereof to the West right of way line of Shelby County Highway No. 87; then turn left and run Southerly along the West line of Highway 87 to the North line of Shelby County Highway No. 12; then turn right and run Westerly, Northerly and Northwesterly along Highway No. 12 to the South boundary line of the City of Alabaster, Alabama, then turn left and run along the boundary line of the City of Alabaster, Alabama, to the point of beginning.

LESS AND EXCEPT all of the N½ of the N½ of the SW½ of the SW½ of Section 29, Township 21 South, Range 2 West, which lies within the boundaries described above, which property excepted was conveyed to Alabama Power Company by deed recorded in Deed Book 305, at page 73 in the Probate Office of Shelby County, Alabama.

Be it further ordained that the corporate limits of the City of Alabaster be extended and rearranged so as to embrace and include such property and such property or territory shall become a part of the corporate area of such municipality upon the date of publication of this Ordinance, as provided for in Sections 11-42-20 and 11-42-21, Code of Alabama 1975.

Be it further ordained that the City Clerk be and she is hereby authorized and directed to file a copy of this ordinance, along with an accurate description of the property or territory being annexed, together with a map of the said territory showing its relationship to the corporate limits of the City of Alabaster to which said territory is being annexed in the office of the Judge of Probate of Shelby County, Alabama.

Be it further Ordained that the Zoning Map of the City of Alabaster, and any other official maps or surveys of the City, shall be amended to reflect the annexation of the above-described property.
