PETITION FOR ANNEXATION

This petition is conditioned upon the granting of the petition for a fifteen-year tax exemption as allowed for in Sections 2, 3 and 4 of Act No. 787 of the 1977 Alabama Legislature (Acts 1977, pp. 1357-1358) with respect to the territory to be annexed.

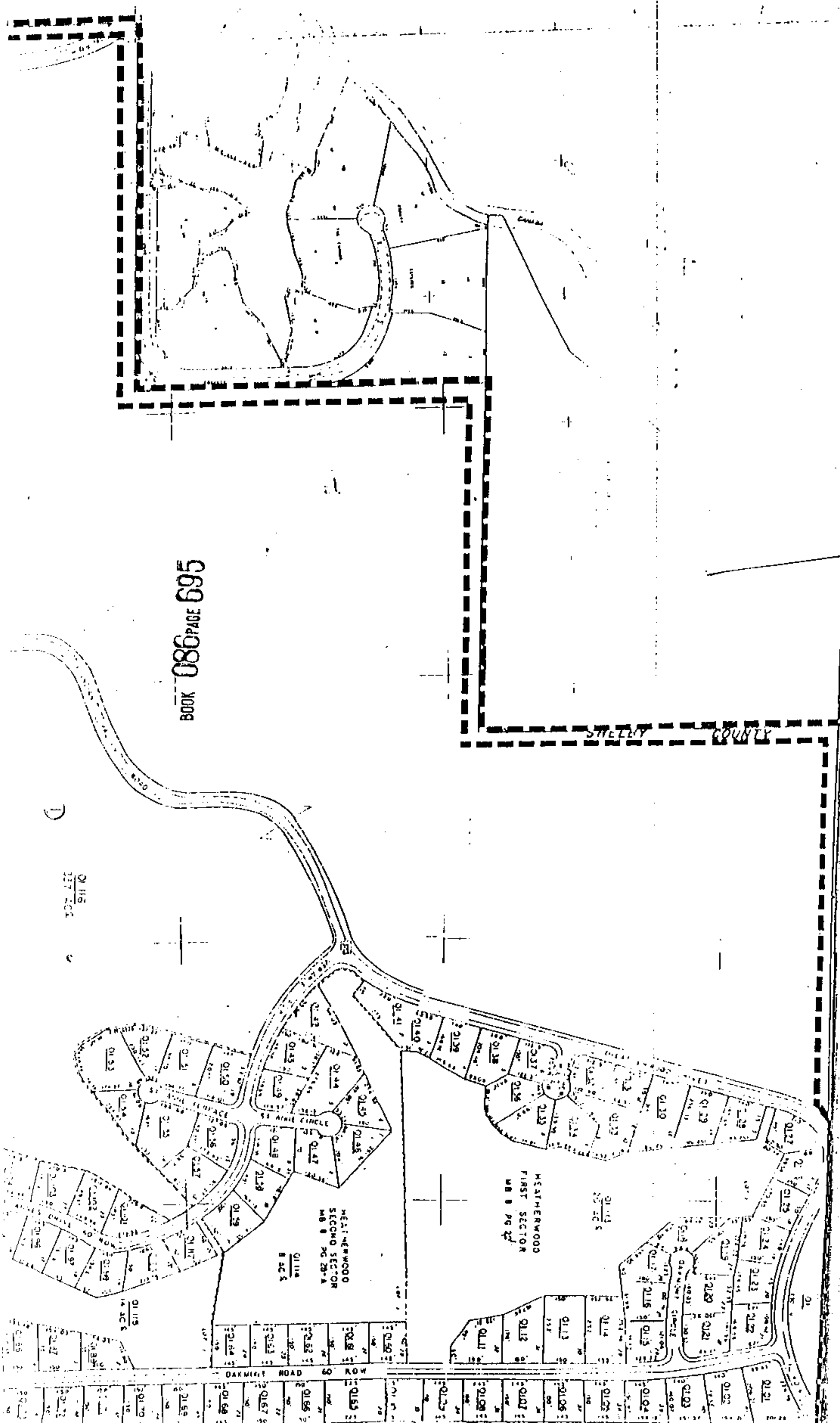

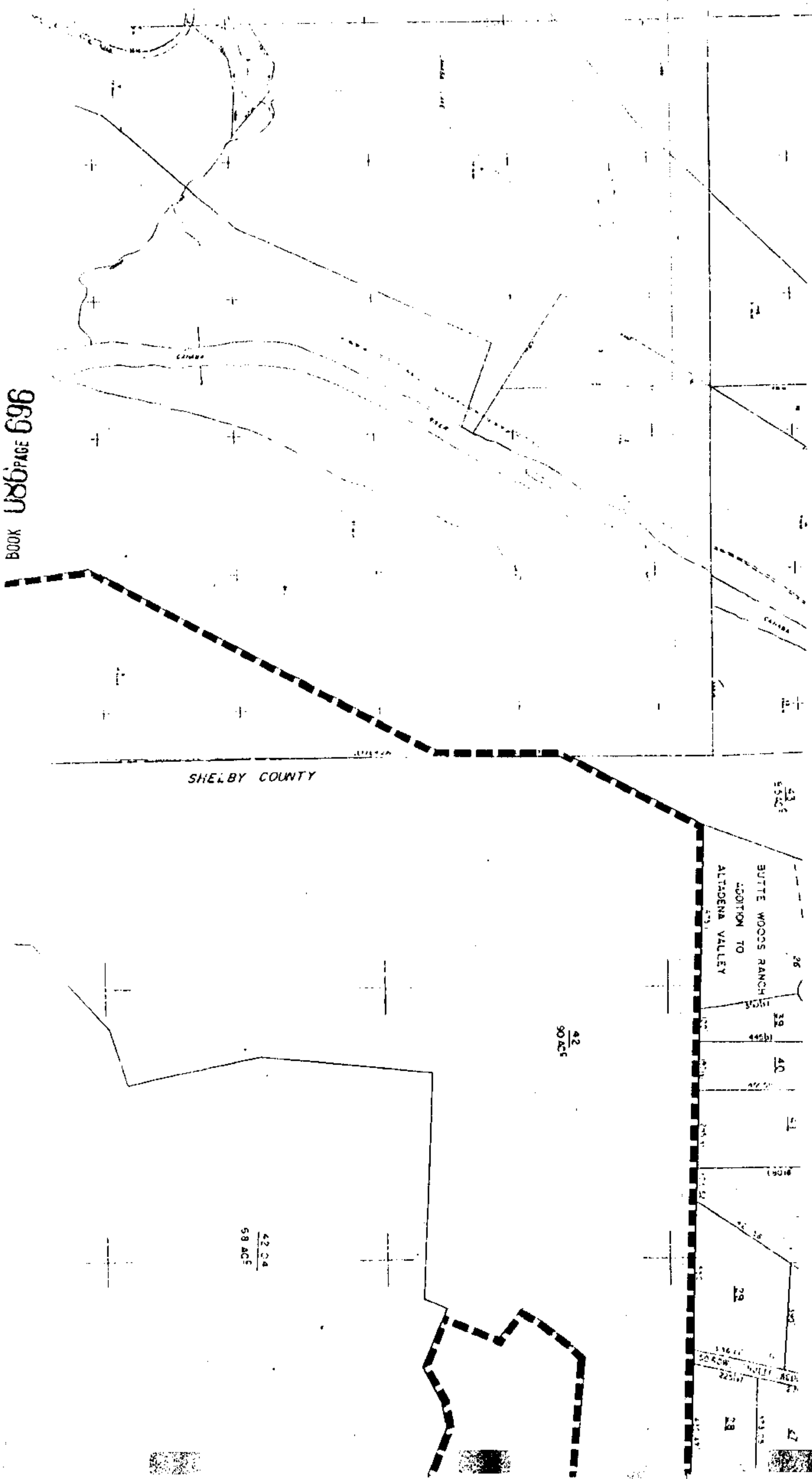
