RELEASE AND TERMINATION AGREEMENT among **THE INDUSTRIAL DEVELOPMENT BOARD OF THE TOWN OF PELHAM**, a public corporation and instrumentality under the laws of the State of Alabama (herein called the "Board"), **C & B LIQUIDATING CO., INC.** (formerly named Cole-Hall Lumber Company, Inc.), a corporation organized and existing under the laws of the State of Alabama (herein called the "Company"), **FIRST ALABAMA BANK**, a banking corporation (herein called the "Trustee"), and **WILLIAM L. COLE** and **EUGENE BRIDGERS, JR.** (herein called the "Guarantors"),

RECITALS

The Board and the Company have heretofore entered into a Lease Agreement dated as of November 1, 1975 (herein called the "Lease"), pursuant to which the Board leased the Project as therein defined (said Project being herein called the "Project") to the Company at and for rentals sufficient to provide for the payment of the principal of and the interest on the Board's Industrial Development Revenue Bond, Cole-Hall Lumber Company, Inc. Project dated November 1, 1975 (herein called the "Bond"). The Bond was secured by a Mortgage and Indenture of Trust dated as of November 1, 1975 (herein called the "Indenture"), between the Board and the First Alabama Bank, Trustee. The Bond has been paid in full pursuant to the applicable provisions of the Indenture, and the Indenture has been satisfied of record. The Board and the Company are entering into this Release and Termination Agreement in order to release and relinquish their respective rights under the Lease and to cancel the same of record. The Lease was filed for record in the office of the Judge of Probate of Shelby County, Alabama, on December 17, 1975, and is there recorded in Real Property Volume 296 at page 77 et seq. As security to the Board and the Trustee for the performance by the Company of its obligations under the Lease, the Board, the Trustee and the Guarantors entered into a Guaranty Agreement dated December 17, 1975 (herein called the "Guaranty Agreement"), pursuant to which the Guarantors guaranteed to the Board and the Trustee the performance of such obligations by the Company.

NOW, THEREFORE, in consideration of the premises and the mutual acknowledgments, agreements and releases herein contained, the parties hereto agree as follows:

FIRST: The Board hereby releases and discharges the Company from (i) the obligation to pay all installments of rent and other charges hereafter becoming due under the Lease and (ii) all other obligations contained in the Lease.

SECOND: The Company hereby releases, remises and relinquishes to the Board all rights to possess and use the Project which the Company may have under the Lease and all other rights therein contained with respect to the Project.

THIRD: All provisions of the Lease are hereby terminated and cancelled as of the date on which this Release and Termination Agreement is delivered on behalf of the parties hereto.

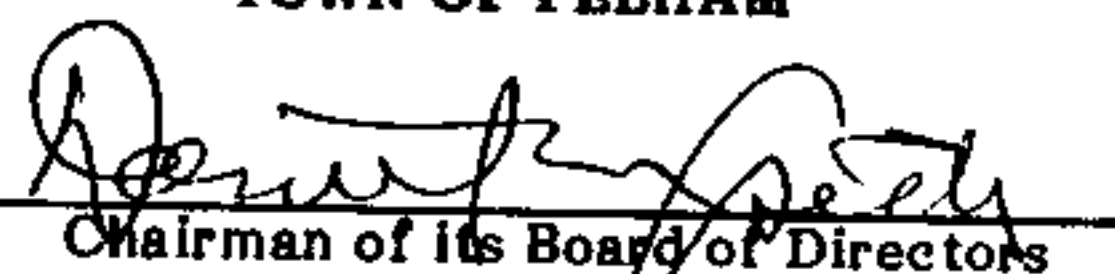

FOURTH: The Board and Trustee hereby release and discharge the Guarantors from all obligations contained in the Guaranty Agreement and all provisions of the Guaranty Agreement are hereby terminated and cancelled as of the date on which this Release and Termination Agreement is delivered on behalf of the parties hereto.

FIFTH: Simultaneously with the delivery of this Release and Termination Agreement, or as soon as practicable thereafter, this Release and Termination Agreement shall be filed for record in the office of the Judge of Probate of Shelby County, Alabama.

IN WITNESS WHEREOF, the Board, the Company, the Trustee and the Guarantors have caused this Release and Termination Agreement to be executed in their respective names, as of April 4, 1986.

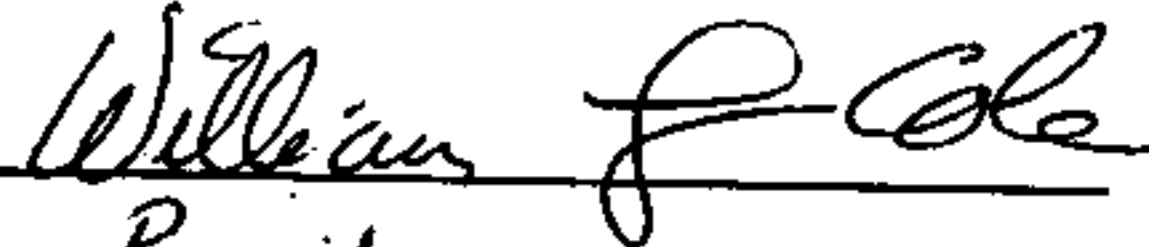

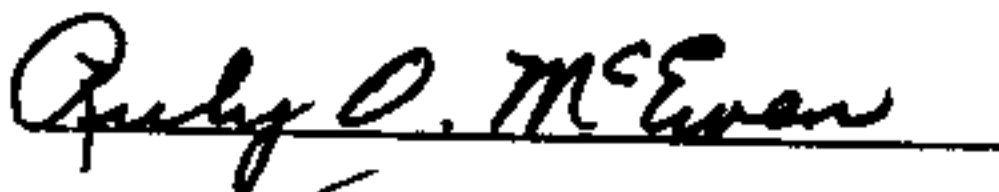
