Kinnebrew hereby grant, bargain, sell, and convey to the said City of Pelham an easement and right-of-way for the purpose of constructing, reconstructing, maintaining and repairing a Sanitary sewer, together with all necessary rights of access, ingress and egress thereto and therefrom, in, over, under and along the following described strip of land situated in the City of Pelham, Shelby County, Alabama:

15 foot wide parcel of land, being seven and one-half (7.5) feet each side of the following described line: Wm. R. Kinnebrew

Commence at the Southeast corner of the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$, Section 36, Township 19 South, Range 3 West, thence run North along the said $\frac{1}{4}$ - $\frac{1}{4}$ Section line a distance of ten (10) feet, thence turn an angle of 90 degrees to the left, and run a distance of 580 feet to the point of beginning, thence continue along last described course a distance of 305 feet to the point of termination.
