KNOW ALL MEN BY THESE PRESENTS: That, whereas The FIRST NATIONAL BANK OF COLUMBIANA
Alabama, hereinafter referred to as Mortgagee, is now the owner of that certain mortgage heretofore executed by

thereby secured being now \$ 419.60 : and,
WHEREAS the undersigned Jerry Wayne Hayes
now the owner, subject to said debt and mortgage, of the property described in and conveyed by said mortgage, an
requested the Mortgagee to grant an extension of time of payment of said mortgage indebtedness as to make the same payable as hereinafter set forth, and the Mortgagee has agreed to grant such extension upon the terms an conditions hereinafter stated:
NOW, THEREFORE, in consideration of the premises and to evidence the agreement of the parties, the undersigne agree—to pay to the Mortgagee or to the successors or assigns of the Mortgagee, the said indebtedness in installments as follows
Whereas, on the 16th day of January 1985, executed a mortgage and a primissory note to the FNB of Columbiana in the principal amount of \$6,226.58, which said sum was payable in 36 installments of \$209.80 each; said installment commencing on the 15th day of Feb. 1985. WHEREAS, 2 of said payments in the amounts of \$209.80 were due on the 15th day of August and September 1986 and said debtor desires to have the time of said installments extended to the 15th day of April and May of 1988; and WHEREAS, said Bank does agree for the date for the payments of said intallment to be extended as provided for above.
The Morfgagee has granted the extension of the time of payment of said mortgage indebtedness upon the following conditions: (1) the property described in said mortgage is owned by the undersigned subject to the debt and mortgage here inabove described; (2) no lien or encumbrance has been placed upon or attached to said property prior to the lien of the mortgage indebtedness hereinabove described; (3) this extension agreement shall have the effect of confirming unto the Mortgage herein named (whether such Mortgagee be designated in the mortgage hereinabove described or has succeeded to the rights of the Morgagee by the transfer and assignment of the Mortgage indebtedness) every right, privilege and benefit conferred upon the Mortgagee in said Mortgage; (4) said mortgage shall be and continue a first lien on the property described herein; (5) said mortgage and all its covenants, terms and conditions shall remain in full force and effect except as herein modified; (6) this instrument shall be of no effect until approved by said Mortgagee; (7) the acceleration provisions in said mortgage remain unmodified by this agreement; (8) If the original maker of the above debt or any other person, in any way or at any time, obligated to pay said original debt signs this agreement, such signature shall be conclusive evidence that such person remains obligated to pay this debt as extended.
