WHEREAS, the Last Will and Testament of Nannie Dee Durden appointed The First National Bank of Birmingham (now AMSOUTH BANK N. A.), Birmingham, Alabama, and Lehman Murray Alley, as Trustee of the said Trust, and

WHEREAS, the Last Will and Testament of Nannie Dee Durden, deceased, Item 5 (3) provided; "...the separate Trust shall be held for said beneficiaries until such time as each of them has attained the age of 25 years, at which time the said Trust shall cease and determine, and the corpus thereof shall be paid over to the beneficiaries outright and free from Trust..", and

WHEREAS, Lehman Murray Alley, III, has on November 3, 1986 reached the age of 25 years and under the terms of the Will of Nannie Dee Durden, deceased, the Trust has terminated, and

THEREFORE, The First National Bank of Birmingham (now AmSouth Bank N. A.), Birmingham, Alabama and Lehman Murray Alley as Trustees of the Nannie Dee Durden Trust for the benefit of Lehman Murray Alley, III, do hereby remise, release, quit claim and convey unto Lehman Murray Allen, III, an undivided 5.5555% interest in the following described property located in Shelby County, Alabama to-wit:

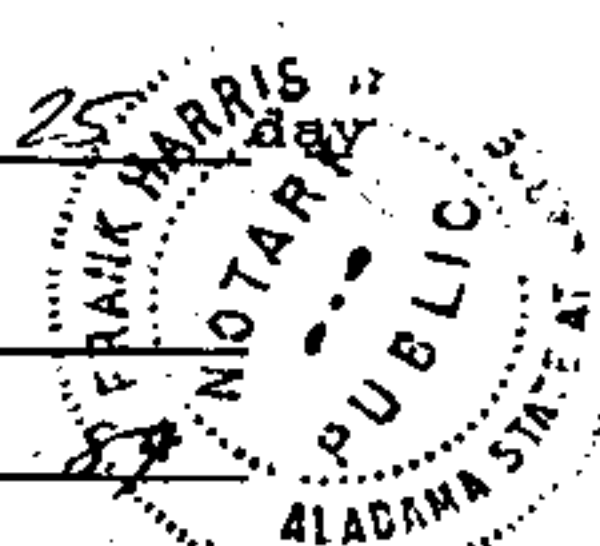
