WITNESSETH:
WHEREAS, it has been found to provide the necessary utilities to certain areas lying within the <u>City of Helena</u>
service area, Shelby County, Alabama; that it has been found
necessary to cross certain lands owned by the Grantors for the purpose of
installing all necessary road improvements , and other such integral
parts of the roadway;
WHEREAS, it has been found advantageous and to the best interest
of Grantors and Grantee that an easement for such road improvements be
conveyed to theCity of Helena, Alabama.
THEREFORE, in consideration of the sum of
and the mutual benefits accruing to the Grantors and to theCity of
Helena,ShelbyCounty, Alabama, the
Grantors have this day bargained and conveyed and by these presents do hereb
grant and convey unto theCity of Helena,Shelby
County, Alabama, the following right, privilege and easement, in, to, along,
over, through, under and across the hereinafter described lands:

The right and privilege to construct, erect, install, operate and maintain the road right-of-way, on, upon, along, over, through, under and across the hereinafter described lands;

The right, privilege and easement to cut, trim and remove any brush, trees, or other obstructions upon the hereinafter described lands, together with the right of ingress and egress to and from, over and above the hereinafter described lands, for the purpose of the installation and upkeep of the road improvements

CORPUS FIGA

A parcel of land located in Sections 27 and 28, T. 20 S., R. 3 W. more particularly described as follows:

Commence at the NE corner, NWt-SEt, Section 28, Township 20 S., Range 3 W., Shelby County, Alabama and run West along the North line of said 1-1 60.85' to the center line of Shelby County Highway 17; thence run Southeast along said center line for a distance of 185.0' more or less; thence turn right and run 40.0' more or less to the point of beginning. Said point being on the East R.O.W. line of Shelby County Highway 17; thence continue along said course for a distance of 259.53' more or less; thence turn right 59°27', and run 175.52'; thence turn left 46°02'30" and run 150.29'; thence turn right 60°24'13" and run 349.86'; thence turn left 32°16'06" and run 843.30'; thence turn left 41°14'15" and run 115.48; thence turn left 48°19'52" and run. 424.95'; thence turn left 17°28' and run 227.42'; thence turn left 05°30'55" and run 346.40', said line being the center line of a 30' right-ofway lying 15' either side of said described line.
