KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of One and no/100 Dollar and other valuable considerations to the undersigned in hand paid by the City of Pelham, a municipal corporation, the receipt whereof is hereby acknowledged, I (we) Neil C. Morgan & the First National Bank of Tuscaloosa, as joint executors of the estate of Earle Morgan, deceased, bargain, sell, and convey to the said City of Pelham an easement and right-of-way for the purpose of constructing, reconstructing, maintaining and repairing a Sanitary sewer, together with all necessary rights of access, ingress and egress thereto and therefrom, in, over, under and along the following described strip of land situated in the City of Pelham, Shelby County, Alabama:

A fifteen (15) feet wide parcel of land being 7.5 feet each side of the following described line: Commence at the Northeast Corner of the SW $\frac{1}{4}$  of the NW $\frac{1}{4}$ , Section 31, Township 19 South, Range 2 West; thence run West along the said  $\frac{1}{4}$  -  $\frac{1}{4}$  section line a distance of 306.37 feet to the point of beginning; thence turn an angle of 99°02'30" to the left and run 185 feet to a point; thence turn an angle to the right of 42°54'51" and run a distance of 229.29 feet to a point; thence turn an angle of 71°46'21" to the left and run a distance of 1096.28 feet to the point of termination.

TO HAVE AND TO HOLD the said easement and right-of-way hereinbefore granted to the said City of Pelham, its successors and assigns forever, for the purpose above mentioned and for no other purpose.

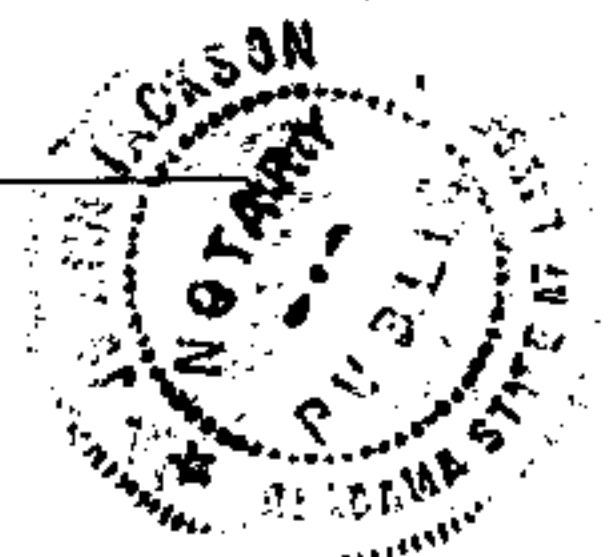
