

ORDINANCE NO. 388 86-562

AN ORDINANCE TO ALTER AND REARRANGE THE BOUNDARY LINE OF THE CITY OF HOOVER, ALABAMA, SO AS TO INCLUDE WITHIN THE CORPORATE LIMITS OF SAID CITY ALL TERRITORY NOW WITHIN SUCH CORPORATE LIMITS AND ALSO CERTAIN TERRITORY IN JEFFERSON COUNTY, ALABAMA.

WHEREAS, this Council does hereby determine that the matters set forth in the petition of H. Wayne and Suzanne B. Burnett and Terry E. & Judy P. Spidle, wherein the owners of the property described therein and hereinafter described in this ordinance requested that said property be annexed to the City of Hoover, are true, and that it is in the public interest that said property be annexed to the City of Hoover,

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Hoover, Alabama, as follows:

SECTION 1. That under the provisions of Title 11-42-21 of the Code of Alabama, 1975, the boundary line of the City of Hoover, Alabama, be and the same is altered and rearranged so as to include within the corporate limits of said City, in addition to the territory included within its present corporate limits, the territory contiguous to said City and not within the corporate limits or police jurisdiction of another municipality more particularly described on Exhibit "A" attached hereto and made a part hereof.

SECTION 2. That the City Clerk shall file a certified copy of the petition requesting the annexation to the City of Hoover of the properties described in Exhibit "A" attached hereto, and a certified copy of this ordinance with the Judges of Probate, Jefferson & Shelby Counties and also cause a copy of this ordinance to be published in a newspaper of general circulation in the City of Hoover.

Exhibit "A"

Parcel I.

Lot 32 except the west 555.00 feet, according to the Map of Cahaba River Estates as recorded in Map Book 3, Pages 32 & 33 in the Jefferson County Probate Office, Bessemer Division. Also a 50.00 foot easement for ingress and egress, being 25.00 feet on each side of the following described centerline:

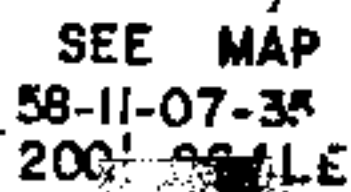

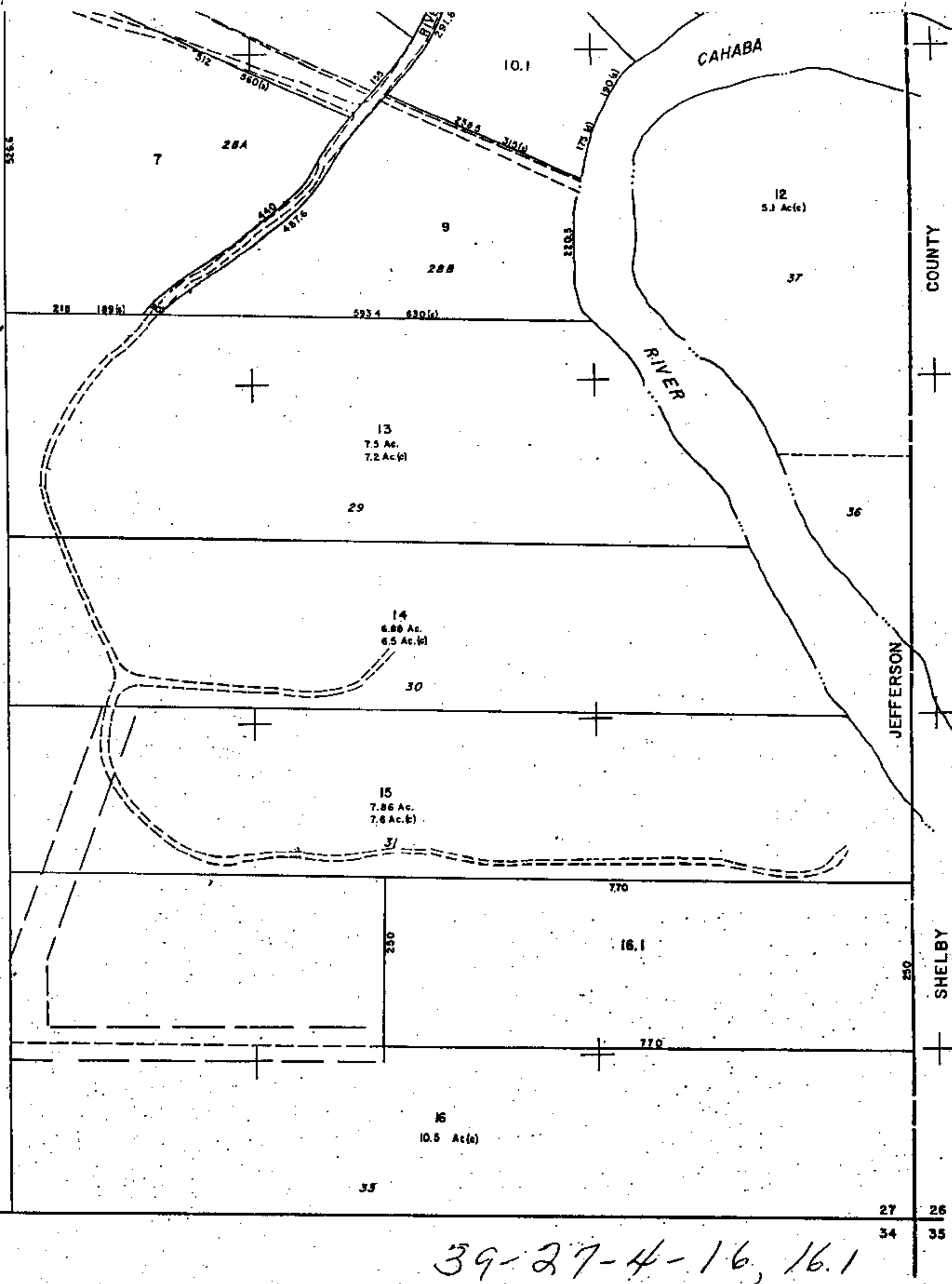

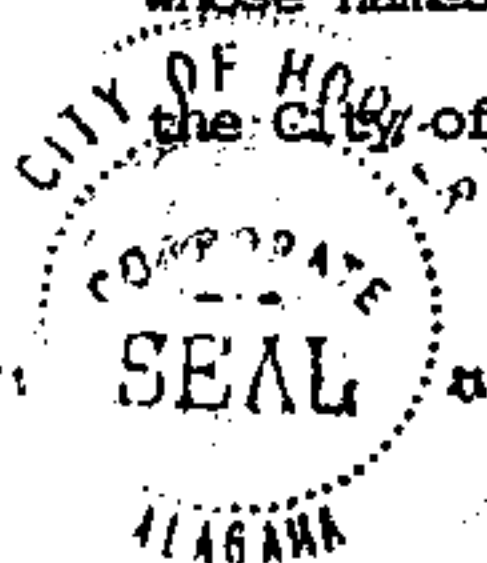
