CONSENT JUDGMENT

The parties, by and through their respective counsel,
having agreed to a consent judgment being entered in the above
referenced matter based on the Settlement Agreement attached
hereto as Exhibit "A," it is hereby

ORDERED, ADJUDGED AND DECREED, that a consent judgment is
hereby entered against Alvin Q. Crumpton, III, and Battery
Distributors, Inc.; and in favor of Battery Specialists of
America, Inc.; in the amount of One Hundred Twenty Thousand
Eight Hundred Ninety-Six and 26/100 Dollars (\$120,896.26),
bearing interest at the rate of Six Percent (6%) per annum;
with monthly installments in the amount of One Thousand One
Hundred and no/100 Dollars (\$1,100.00) commencing on the 10th
day of November, 1986, and continuing until the 10th
day of August, 1987, at which time said monthly
installments will be increased to the amount of One Thousand
Six Hundred and no/100 Dollars (\$1,600.00) and continuing each
month thereafter until paid in full. The following additional
terms and conditions will exist with regard to this Consent

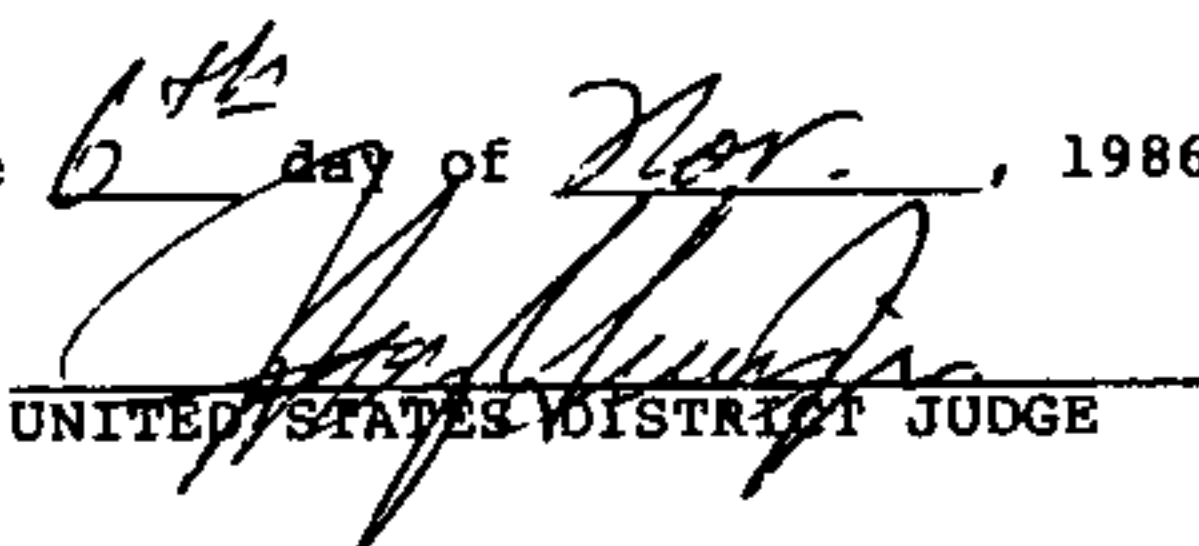

Judgment:

- A. That the Plaintiff agrees to allow a ten (10) day "grace period" in order to receive said monthly payments.
- B. There will be certain rebates and credits based on volume buying which will be credited to this judgment.
- C. Plaintiff will sell to the Defendants on a "cash-on-delivery" basis only until payment in full of this consent judgment.
- D. Plaintiff agrees to withhold execution as long as the terms of this consent judgment are met and honored. In the event Defendants fail to make said monthly installments, Plaintiff may begin lawful execution or garnishments against said Defendants. Plaintiff is granted the right to record this judgment.
