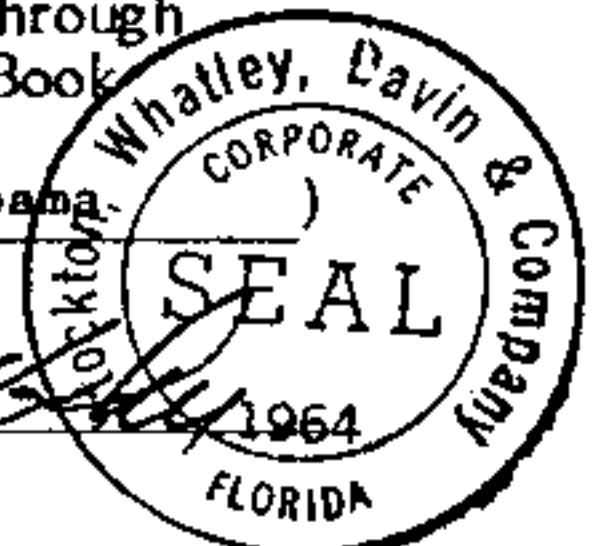
The said mortgage and the indebtedness thereby secured are hereby cancelled, released and discharged.
