daughter-in-law, Lana Whisman, as beneficiaries of her estate.

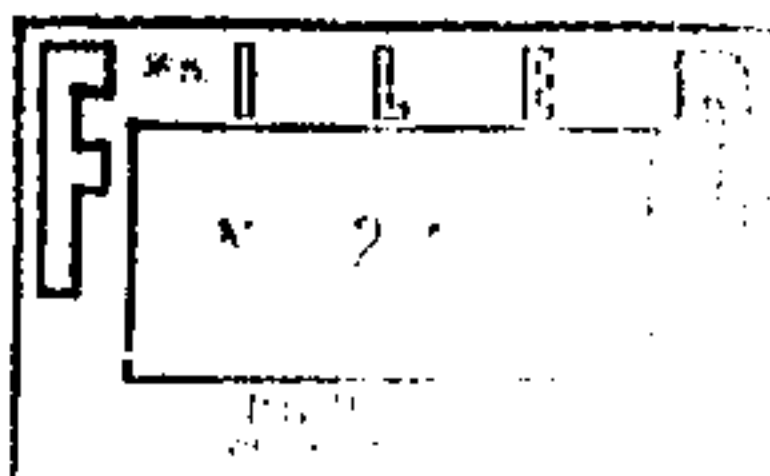
3. Decedent's Property. The Decedent's property

THEREFORE, Petitioners REQUEST THAT:

A. The testimony of witnesses regarding the authenticity of the Decedent's handwriting and holographic will be accepted by the Court for the purpose of proving and establishing the Will, and that probate of the Will may be granted and the probate and Will ordered for record;

B. The Court be directed to administer the oath and otherwise qualify the Petitioners as the Co-Executors and to issue letters testamentary;

C. Notice by publication be given to the creditors of the Estate as required by T.C.A. 30-2-306, and notice be given to the Department of Revenue as required by T.C.A. 67-8-406;

D. The requirements of an inventory and interim accountings be waived;

E. The requirements of bond for the Personal Representative be waived;

F. The Court grant Petitioners such additional and further relief the Court considers proper under the circumstances.

I, Edwina W. Whisman, a citizen and resident of Bradley County, Tennessee, being of sound mind and having testamentary capacity, do hereby make, declare and publish this my last will and Testament, and revoke any and all previous testamentary dispositions made by me.

I direct that all of my just debts, if any, including my funeral and burial expenses, taxes and cost of administering my estate be first paid.

I direct that all debts owed to my Estate by any of my three children (- This includes Lana Whisman, the child of my heart, and my two sons, Bruce Whisman and Stephen Whisman) be forgiven as non-existent.

I direct that my residence, located at Paducah, Tennessee shall be bequeathed to Lana and/or Bruce Whisman with right of survivorship to either Bruce or Lana.

I direct that the Cert. of Deposit at Home Federal in Blue Ridge, Ga., be bequeathed to Bruce and Lana Whisman.

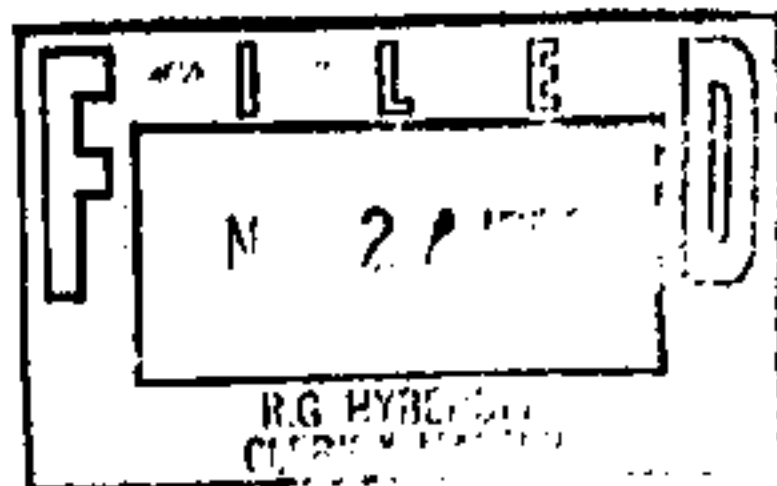

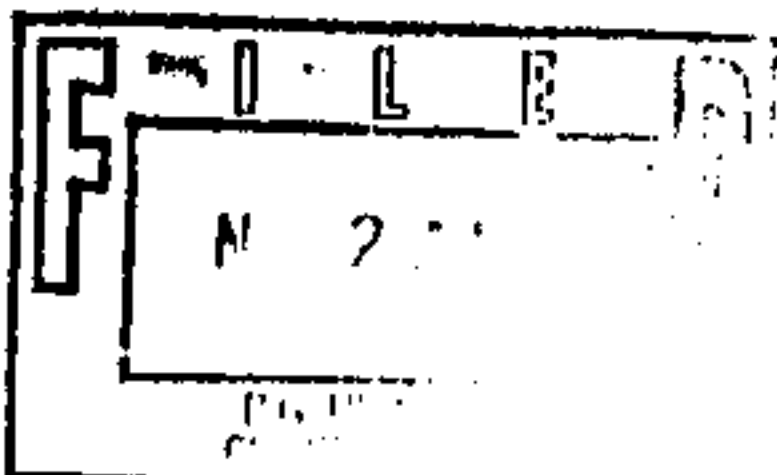
ORDER ADMITTING WILL TO PROBATE

Based on an examination of the Petition, the Decedent's last Will, the sworn testimony of two disinterested witnesses, and sworn testimony of Petitioners on Nov. 24, 1986, the Court finds:

1. Decedent was a resident of Bradley County, Tennessee.
2. Decedent died on October 14, 1986, at the age of 66.
3. The Decedent left a holographic Will dated July 12, 1986, which was written entirely in Defendant's handwriting.
4. Petitioners were appointed Co-Executors in the last paragraph of the Decedent's Will, and were excused from bond in the last paragraph of the Decedent's Will.
5. Decedent owned property at Decedent's death which is subject to Court supervised administration by this Court worth approximately Sixty Thousand (\$60,000) Dollars.
6. The Beneficiaries of the Estate are all Class A.

Based on these findings, the COURT ORDERS:

- A. Decedent's Will dated July 12, 1986, be admitted to Probate.
- B. After issuing the oath to Petitioners, Letters Testamentary will be issued to William Bruce Whisman and Stephen Wallace Whisman as Co-Executors.
- C. All bonds are excused.



D. Notice be issued to creditors and to the Department of Revenue as required by T.C.A. 30-2-306 and 67-8-406 respectively.

E. The requirement of an inventory is waived.
