FIRST: The name of this corporation is SHELBY VOLUNTEER FIRE AND RESCUE DEPARTMENT, INC.

SECOND: An amendment has been duly adopted changing Section 1 of Article III, Governing Body, of the Articles of Incorporation to read and to be as follows:

"Section 1. The Governing Body of the Corporation shall be the Board of Advisors (hereinafter called the 'the Board') composed of members of the community, one of whom shall be the Chairman. The number of members of the Board may be increased or decreased from time to time as provided in or by amendment to the By-Laws, provided that the minimum number of members shall be three or more at all times."


