AFFIDAVIT

Before me the undersigned Notary Public, in and for said County and State, personally appeared Margie J. Bentley who after being by me first duly sworn, deposes and says as follows:

1. My name is Margie J. Bentley and I am the wife of William G. Bentley.
2. That I owned jointly the property at The Hole Lay Port, Alabama more particularly described as follows:
