- 1) the entire gas distribution system presently owned by the Grantor to distribute gas in and about the City of Montevallo, excepting cash on hand and deposits in the hands of the grantor, accounts receivable, notes receivable, accounts payable, and notes payable. Grantee does not assume any of grantor's obligations pursuant to existing extension agreements requiring construction advances or deposits. Included within "the entire gas distribution system" are:
- 2) the grantor's rights under that certain agreement executed by the Southern Natural Gas Company on September 13, 1967, and as amended thereafter, providing for the sale of natural gas to the City of Montevallo and for the use by the grantor of an odorizing station located adjacent to the Southern Natural Gas Company's transfer point on the north margin of Alabama Highway 25 near Blue Circle Lime between Montevallo and Calera.
 - 3) all the pipes, valves, meters, and equipment belonging to grantor and used in the distribution of gas, whether attached to realty or not.
 - 4) that certain gas regulating station, including pipes, valves, and a surrounding chain link fence topped with three strands of barbed wire, six and a half feet tall, forming a rectangle ten feet on a side oriented east to west, and eleven feet on a side oriented north to south, twenty feet from the pavement of Oak Street and thirty feet from the pavement of Ashville Road (Ala Hwy 119) located within Lot 1, Block P of Lyman's addition to the Town of Montevallo according to a map recorded at Map Book 3, page 27 in the Probate Office of Shelby County, Alabama, and further described as being on the SW corner of Ashville Road and Oak Street, in \$21, Twp 22S, R3W, in the City of Montevallo, Shelby County, Alabama.
