MEMORANDUM OF LEASE

the last stated course a distance of 112.30 feet to a point, thence 117
degrees 04 minutes to the right in a Southwesterly direction a distance
of 273.05 feet to a point on the Northeasterly right of way line of U.S.
Highway No. 280; thence 89 degrees 59 minutes to the right in a
Northwesterly direction along the Northeasterly right of way line of U.S.
Highway No. 280 a distance of 100.00 feet to a point; thence 90 degrees
01 minutes to the right in a Northeasterly direction a distance of 221.98
feet to the point of beginning.

to have and to hold for a term of fifteen (15) years beginning on
the 5th day of May, 1986, and ending on the
4th day of May, 2001.

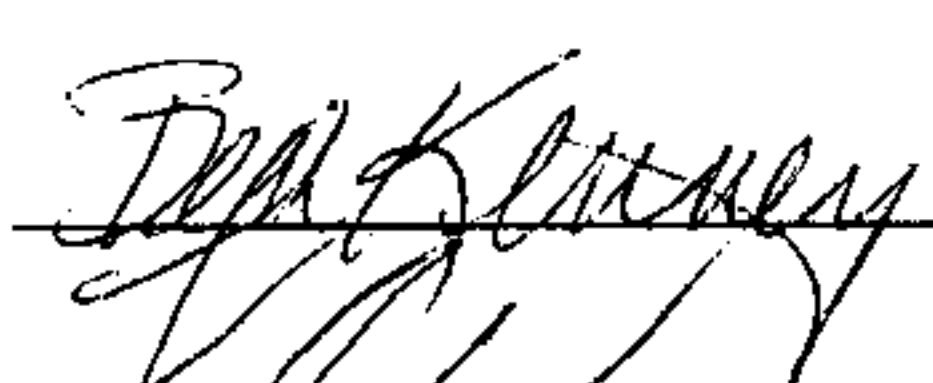
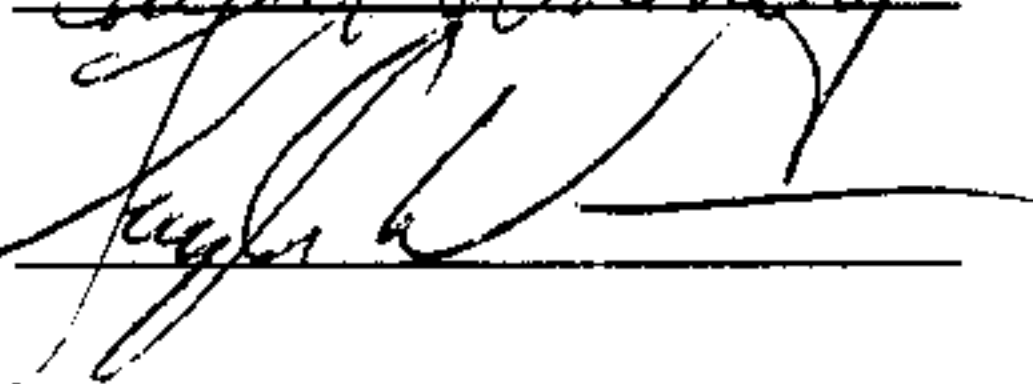

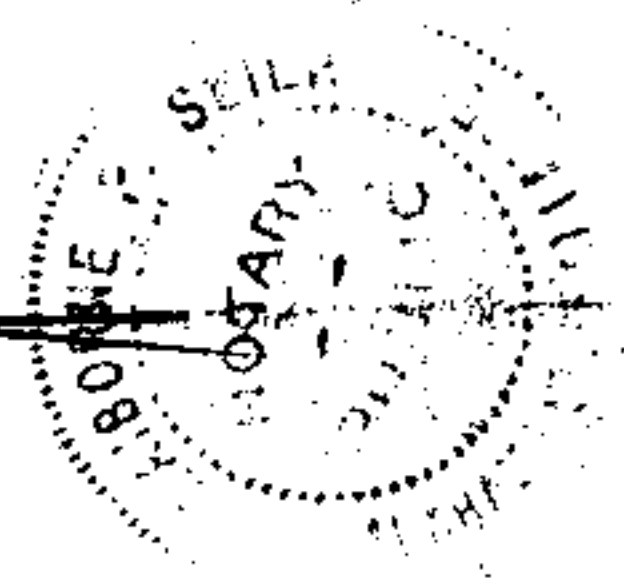
