ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION FIRST AMERICAN BANCSHARES, INC.

Pursuant to the provisions of Section 10-2A-113 of the Code of Alabama, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is First American Bancshares, Inc.
- 2. The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on October 21, 1986, in the manner prescribed by the Alabama Business Corporation Act.

"Fourth: Shares of Stock." is amended to read as follows:

"The maximum aggregate number of shares of Common Stock which the corporation shall have authority to issue is One Hundred Thousand (100,000) shares of the par value of One Dollar (\$1.00) per share. No shares have preemptive rights."

- 3. The number of the shares of the corporation outstanding at the time of such adoption was 67,503 shares of Common Stock; and the number of shares entitled to vote thereon was 67,503. The corporation has only one class of stock.
- 4. The number of shares voted for such amendment was $\frac{56,281}{}$; and the number of shares voted against such amendment was $\frac{56,281}{}$.
- 5. The manner in which such amendment effects a change in the amount of stated capital and the amount of stated capital changed by such amendment are as follows: Stated capital is decreased by \$438,769.50 as follows: The corporation currently has 67,503 shares of Common Stock issued and outstanding, and by reducing the par value from \$7.50 to \$1.00 per share, the stated capital with respect to these shares is reduced from \$506,272.50 to \$67,503.
