**Certificate of Judgment**

I, GENE E. BELL, Acting Clerk of the United States District Court for the Northern District of Alabama, do hereby certify that on the fifteenth day of April, 1986, a Consent Judgment was rendered by said Court in the above-styled cause wherein UNITED STATES OF AMERICA obtained a judgment against ANN C. CORRERO f/k/a ANN C. SHAW whose address is Post Office Box 213, Pelham, Alabama 35124, as shown in the Court proceeding for the sum of THREE THOUSAND ONE HUNDRED EIGHT AND 21/100 (\$3,108.21) DOLLARS, accrued interest of ONE THOUSAND SIX HUNDRED FORTY AND 38/100 (\$1,640.38) DOLLARS as of August 18, 1985 and thereafter at the rate of 7% per annum until date of judgment. Interest shall accrue at the prevailing legal rate of 6.31% from date of judgment until paid in full; and that Defendant will satisfy this judgment by making consecutive monthly payments of TWENTY AND 00/100 (\$20.00) DOLLARS each commencing May 2, 1986 payments subject to increase after six months in proportion to income; and that should Defendant default in making any one of the above-described monthly payments, the entire unsatisfied amount of this judgment shall become immediately due and payable; and that payment of the proceeds of this judgment shall be made directly to the attorneys of record for the Plaintiff and that, upon receipt thereof, such attorneys will satisfy said judgment on the records of this Court; and that Frank W. Donaldson, United States Attorney for the Northern District of Alabama, is the Attorney of Record for the UNITED STATES OF AMERICA in said cause.

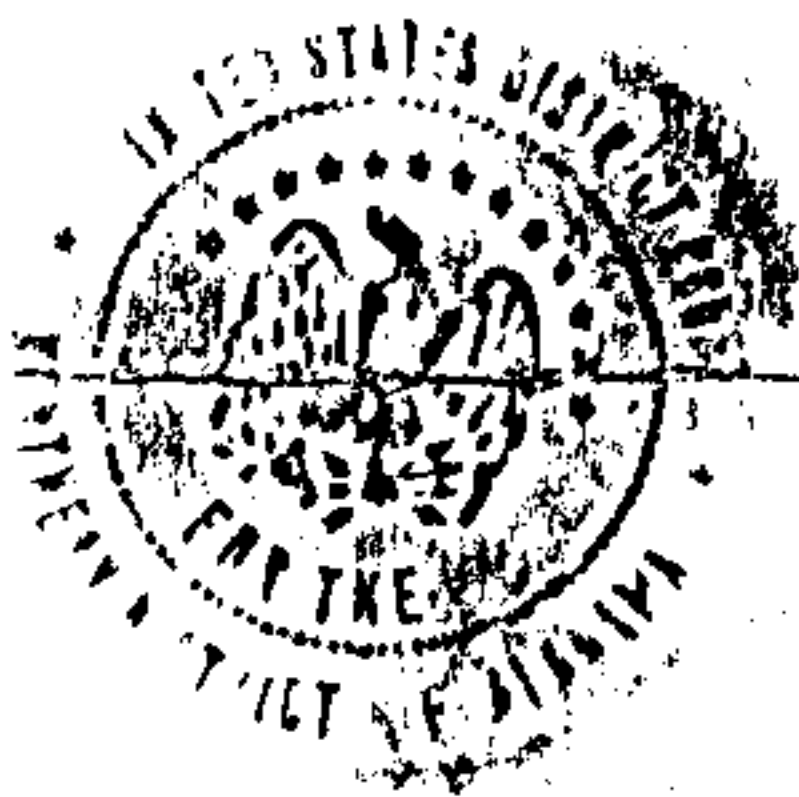
