its true and lawful Attorney(s)-in-Fact, with full power and authority for and on behalf of the company as Surety, to execute and deliver and affix the seal of the company thereto if a seal is required, bonds, undertakings, recognizances or other written obligations in the nature thereof, as follows: Not exceeding Two Hundred and Fifty Thousand Dollars (\$250,088,00);

and to bind LAWYERS SURETY CORPORATION of Dallas, Texas, thereby, and of the acts of said Attorneys-in-Fact, pursuant to these presents, are hereby ratified and confirmed. This appointment is made upder and by authority of the following provisions of the By-Laws of the company, which are now in full force and effect:
