To The Honorable Bobby Hayes, Mayor of the City of Pelham, Alabama and the Council Members of the City of Pelham, Alabama.

Now comes the undersigned Sherman Holland, Jr., being hereinafter referred to as the Petitioner, who presents unto your honors, the following statement, to-wit:

That the Petitioner is the owner of all the property abutting upon the following described road; and that the Petitioner desires to vacate the following described road, and that Petitioner, by this statement, vacates the same, such road being in the City of Pelham, Alabama, and described as follows, to-wit:

That certain unpaved, unnamed road, being located in the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$, Section 25, T20S, Range 3 W, and the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 26, T20S, Range 3 W, and the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$, of Section 26, T20S, Range 3 W, more particularly described as follows: Begin at the Westernmost point of Keystone Street as it intersects with the right-of-way of the Land N Railroad thence continue in a Westerly and Southwesterly direction over the meanderings of said road as it passes through the quarter sections outlined above to the point of the East bank of Buck Creek, continue across wooden bridge and continue in a Southwesterly direction to the City limits of Pelham, Alabama. Such road hereby described being located upon and through lands owned fully by the Petitioner. All being located in the City limits of Pelham, Alabama.

That the undersigned Petitioner desires to vacate and to divest all public rights, including any rights which may have been acquired by prescription, to the use of the public.

Petitioner further represents that such vacation does not deprive other property owners of convenient and reasonable means of ingress and egress to and from their property.

Now Therefore, in consideration of the premises, Petitioner hereby requests that your Honors assent to, approve, ratify and confirm the vacation of the above-described unpaved road to the use of the public.
