That in consideration of THIRTY-TWO THOUSAND AND NO/100 DOLLARS (\$32,000.00) to the undersigned GRANTOR, MOUNTAIN OAKS DEVELOPMENT COMPANY, An Alabama Partnership composed only of Jerry Lucas and Charles R. Saunders, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto

CHARLES J. LANZI, JR. and wife, DEBRA LYNN LANZI

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:
