(hereinafter called Grantee), all my right, title, interest and claim in or to the following described real estate, situated in Shelby County, Alabama, to-wit:

A part of the NE 1/4 of NE 1/4 of Section 3, Township 24 North, Range 13 East, more particularly described as follows: Begin at the intersection of the East line of Block 263 with the South line of 20th Avenue, according to J. H. Dunstan's map of the Town of Calera, Alabama; thence run Easterly along the South boundary of said 20th Avenue a distance of 90 feet to a point, being the point of beginning, (said point also being the NE corner of lands described in Deed Book 246, Page 665 from Jessie Frost Sorrell to A.
