

AGREEMENT AND ARTICLES OF MERGER BETWEEN
COMMANDER AVIATION CORPORATION AND
GULF AVIATION, INC.

KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, as President of Gulf Aviation, Inc., a corporation organized and existing under the laws of the State of Alabama (hereinafter known as the "Surviving Corporation") and successor by merger to Commander Aviation Corporation, a corporation organized and existing under the laws of the State of Alabama (hereinafter known as the "Merging Corporation"), do hereby certify that, in accordance with the Code of Alabama 1975, Section 10-2A-95, the Agreement and Articles of Merger between said Corporations, as filed in the Office of the Secretary of State of the State of Alabama on the 1st day of April, 1987, is hereby corrected to rectify certain errors made through accident or inadvertence, whether clerical or otherwise, described hereinbelow:

Page 6 of the Agreement and Articles of Merger was inadvertently left out of the filed Agreement and Articles of Merger and should be added to the Agreement. Page 6 reads as follows:
