(herein referred to as "the Association") was held at 6:30 P.M. on March 5, 1987 at The House of Plenty in Columbiana, Alabama, which meeting was attended by more than one-half of the active membership. The Chairman announced that written notice stating the purposes of this special meeting, as hereinafter to be restated by him, had been given to each member of the Association 21 days in advance of this meeting, giving notice of the date, time and place of this meeting and the special purposes for which it was called. The Chairman announced that the special purposes of this meeting are: (a) To consider a recommendation by the Board of Trustees of the Association that the Association be dissolved; and, (b) to consider the recommendation of the Board of Trustees of this Association for a plan of distribution of assets of this Association upon it being dissolved. Further, that a Statement of Intent to Dissolve shall be executed on behalf of this Association by its Chairman, its Fair Manager and its Treasurer/Assistant Secretary, which shall be then delivered to the Office of the Judge of Probate in Shelby County, Alabama for filing. Upon filing of this Statement of Intent to Dissolve, this Association shall cease to conduct its affairs except insofar as may be necessary for the winding up thereof, and shall proceed to collect its assets and apply and distribute them in the manner provided by the following Resolution.

BE IT FURTHER RESOLVED by the membership of the Shelby County Fair Association, an Alabama nonprofit corporation, that the assets of this Association shall be distributed in accordance with Article 9 of the Amended Constitution and By-Laws of this Association. Accordingly, the assets of this Association are hereby transferred to the Kiwanis Club of Columbiana, Inc., an Alabama nonprofit corporation, to be used by Kiwanis Club of Columbiana for (a) improvement of the Shelby County Fair, (b) increasing the premium list and furthering the growth, expansion and usefulness of the Shelby County Fair, and (c) with the remainder of the accumulated profits on hand and future annual profits to be used for community betterment, for development of scholarships, and for civic, charitable, educational, religious and


