SHERIFF'S DEED

KNOW ALL MEN BY THESE PRESENTS, THAT WHEREAS, an execution was duly issued from the Circuit Court of Jefferson County, Alabama against Marjorie Peters in favor of Kahn Properties, Inc. on a judgment rendered in said Court on the 13th day of February, 1986, for the sum of Twenty-Five Thousand, One Hundred, Seventy-Two and 87/100 Dollars (\$25,172.87), besides costs of suit, and post-judgment interest of \$3,930.73; and

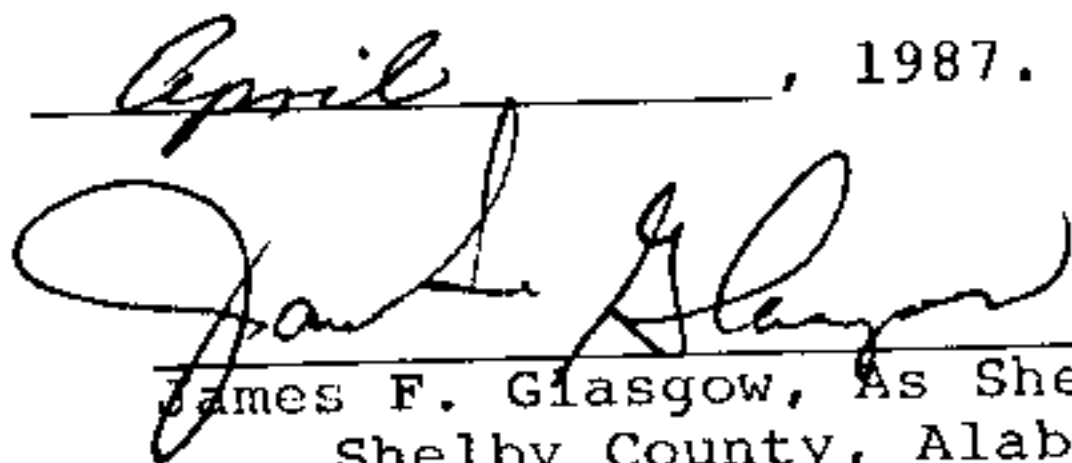
