To Have And To Hold the above granted property unto the said Mortgagee, Mortgagee's successors, heirs, and assigns forever; and for the purpose of further securing the payment of said indebtedness, the undersigned agrees to pay all taxes or assessments when imposed legally upon said premises, and should default be made in the payment of same, the said Mortgagee may at Mortgagee's option pay off the same; and to further secure said indebtedness, first above named undersigned agrees to keep the improvements on said real estate insured against loss or damage by fire, lightning and tornado for the fair and reasonable insurable value thereof, in companies satisfactory to the Mortgagee, with loss, if any, payable to said Mortgagee; as Mortgagee's interest may appear, and to promptly deliver said policies, or any renewal of said policies to said Mortgagee; and if undersigned fail to keep said property insured as above specified, or fail to deliver said insurance policies to said Mortgagee, then the said Mortgagee, or assigns, may at Mortgagee's option insure said property for said sum, for Mortgagee's own benefit, the policy if collected, to be credited on said indebtedness, less cost of collecting same; all amounts so expended by said Mortgagee for taxes, assessments or insurance, shall become a debt to said Mortgagee or assigns, additional to the debt hereby specially secured, and shall be covered by this Mortgage, and bear interest from date of payment by said Mortgagee, or assigns, and be at once due and payable.

A lot or parcel of land lying and being situated in the SW 1/4 of the SW 1/4 of Section 14, Township 23 North, Range 12 East, Chilton County, Alabama and being more particularly described as follows: From the SW corner of said quarter-quarter section as point of beginning run E along the S line of said quarter-quarter section for 1229 feet to a point where a fence depicting the E line of said quarter-quarter section if extended would intersect said line; run thence N01°03'E along said fence extension for 200 feet to a point on the Westerly edge of an unpaved private drive, said point being the SE corner of the Henley lot; run thence S75°30'W along the S line of said Henley lot for 494.6 feet; thence continue along said Henley lot W for 723 feet; thence run N 01°03'E along the W line of said Henley lot for 422 feet; thence run S71°28'E along the N line of said Henley lot for 450 feet; thence continue along said Henley lot line N71°21'E for 563.8 feet to a point in the centerline of a paved public road; run thence in a Northwesterly direction along said line of said road (a curve concave to the left) for 367 feet; thence leaving said road, run S 40°15'W along the S line of Boyd lot for 309.7 feet; thence run S18°22'W along said Boyd lot line for 54.7 feet; thence continue along the S line of said Boyd lot line for 556 feet to a point on the W line of said quarter-quarter section (a fence); run thence S01°03'W along said W quarter-quarter line for 563 feet and to the point of beginning and containing 8 acres, more or less.
