This came to be heard upon regular fixing March 13, 1985.

PRESENT: RALEIGH NEWMAN, Attorney for DYER D. DAVIDSON,
and NICK PIZZOLATTO, Attorney for FRANK DEFOOR;

After considering the pleadings and hearing the evidence,
the Court being of the opinion that the law and evidence
are in favor thereof, for the reasons orally assigned:

IT IS ORDERED, ADJUDGED AND DECREED that DYER D.
DAVIDSON is recognized as the owner of the property described
as follows:

Commencing at a point 600 feet South and 254 feet
West of the Northeast corner of the Northwest
Quarter of the Northwest Quarter of Section 25,
Township 9 South, Range 9 West; thence South 180
feet; thence West 85 feet; thence North 180 feet;
thence East 85 feet along the south line of River
Oaks Drive to point of commencement, Calcasieu
Parish, Louisiana.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that
defendant, FRANK DEFOOR, vacate the premises immediately.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that there
be judgment herein in favor of DYER D. DAVIDSON and against
FRANK DEFOOR ordering Frank DeFoor to pay the sum of FOUR
THOUSAND ONE HUNDRED SIXTY SIX AND 39/100 (\$4,166.38)
plus legal interest from date of judicial demand of November
8, 1983 together with all costs of these proceedings.
