A ten (10) foot wide parcel of land which lies five (5) feet each side of a line which intersects the North Property line 120.09 feet East of the NW corner and the South Property Line 115.60 feet East of the SW Corner of Lot 6, Block 1, Cahaba Valley Estates, Second Sector; situated in the N $\frac{1}{2}$ of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$, Section 12, Township 20 South, Range 3 West, Shelby County, Alabama.
