AFFIDAVIT OF W. F. GRIFFIN

Before me, the undersigned authority, in and for said County and State personally appeared W. F. Griffin, who, being known to me and being by me first duly sworn, deposes and says as follows:

My name is W. F. Griffin, and I am 41 years of age. I am currently the business manager and executive financial secretary for the United Brotherhood of Carpenters and Joiners of America, Local Union #127. This new local union became effective in March, 1987. Prior to my position with the new local union, I was the business manager and executive financial secretary for the Jefferson County District Council of the United Brotherhood of Carpenters and Joiners of America, of which Local Union #2227 was a part along with several other local unions.

By executive order of the General President of the United Brotherhood of Carpenters and Joiners of America, Honorable Patrick J. Campbell, the Jefferson County District Council, and its affiliated local unions, with the exception of Millwright's Local #1192, was disbanded and consolidated into Local Union #127. The charters for the aforementioned affiliated unions of the Jefferson County District Council was revoked, and a new charter was issued for Local Union #127 consolidating the prior local unions. By this action, Local Union #2227 of the United Brotherhood of Carpenters and Joiners of America was effectively merged and consolidated with United Brotherhood of Carpenters and Joiners, Local Union #127.

The constitution of the United Brotherhood of Carpenters and Joiners of America gives the General President the authority to issue an executive order disbanding, consolidating and creating local unions. The

consolidation of the affiliated local unions of the Jefferson County District Council, including Local Union #2227 with Local Union #127 was done entirely according to the constitution and executive order mentioned herein.

The trustees of United Brotherhood of Carpenters and Joiners, Local Union #2227 conveyed certain real property to the Trustees of Local Union #127 by virtue of a deed as recorded in Real Book 122, page 100, Probate Office of Shelby County, Alabama. The purpose of this conveyance was simply to transfer property from old Local Union #2227 to the new Local #127 of which it is now a part. Further, Carpenters Local Union #127, and United Brotherhood of Carpenters and Joiners of America, Local Union #127 are one and the same and are referred to in either manner. Douglas Akers, William M. Eddy, Jr., and Wendell Farley are presently the trustees of said local union.
