EXHIBIT - B

Commence at the intersection of the centerline of the Cahaba River and the east line of the southwest one-quarter of Section 4, Township 20 South, Range 3 West; thence run north along the east line of said quarter section line to a point that is 175 feet northwesterly of and perpendicular to the center line of the Cahaba River, said point being the point of beginning; from the point of beginning thus obtained continue north along the east line of the southwest one-quarter of Section 4, Township 20 South, Range 3 West to a point that is 350 feet northwesterly of and perpendicular to the centerline of the Cahaba River; thence run in a southwesterly direction, parallel to and 350 feet northwesterly of the centerline of the Cahaba River to its intersection with a line 350 feet north of the south line of Section 4, Township 20 South, Range 3 West; thence run westerly, parallel to and 350 feet northerly of the south line of said Section 4 to its intersection with the west line of Section 4, Township 20 South, Range 3 West; thence run south along the west line of said Section 4 to a point that is 175 feet north of the south line of said Section 4; thence run east parallel to and 175 feet northerly of the south line of said Section 4 to its intersection with a line 175 feet perpendicular to and parallel with the centerline of the Cahaba River; thence run in a northeasterly direction along a line parallel with and 175 feet northwesterly of the centerline of the Cahaba River to the point of beginning.

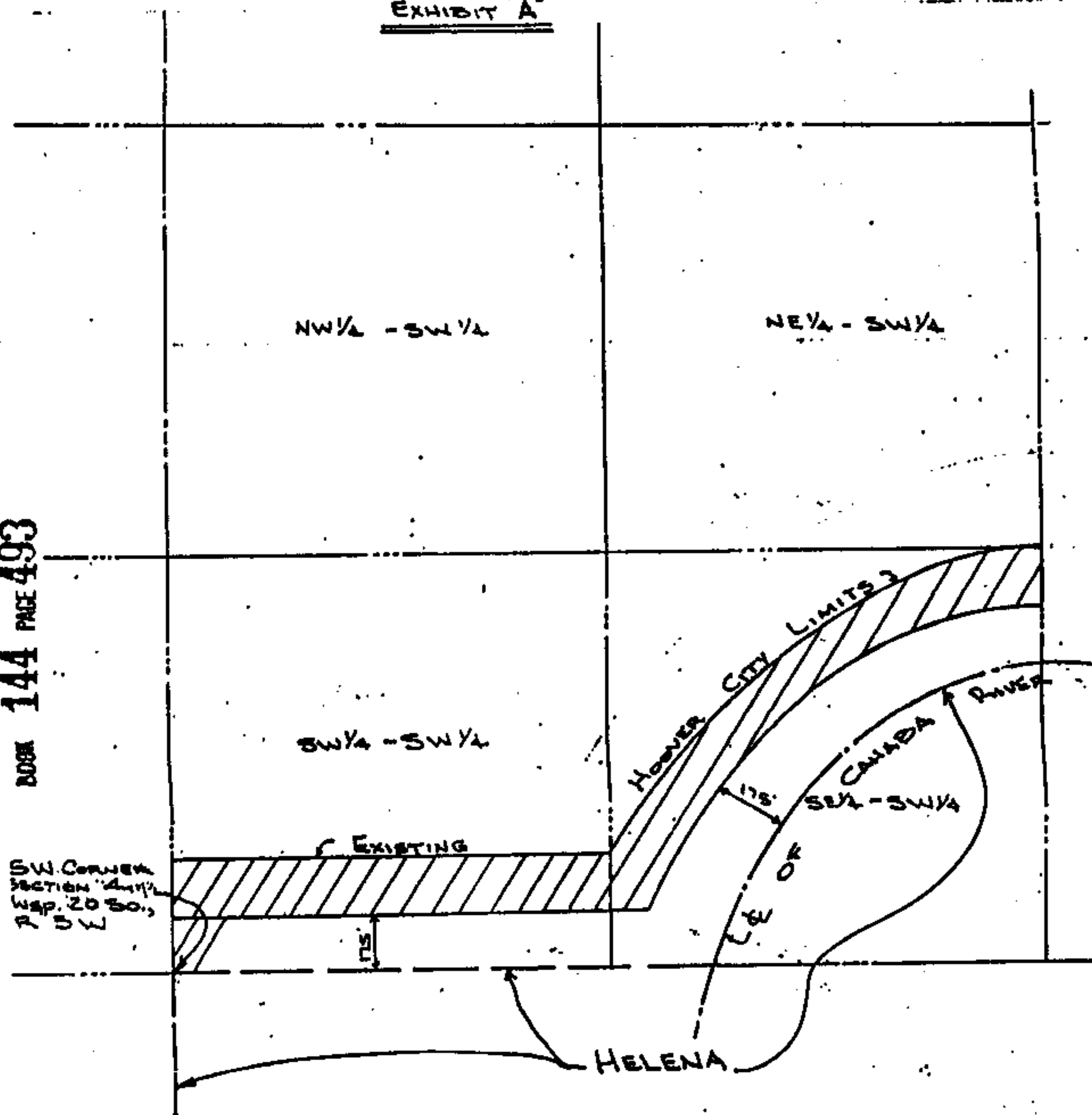
