WHEREAS, there is attached to the said petition a map of said territory showing its relationship to the corporate limits of the City; and

WHEREAS, this Council has determined and found that the matters set forth and alleged in the said petition are true and that it is in the public interest that said property be annexed into the City of Hoover;

NOW THEREFORE, be it ordained by the Council of the City of Hoover as follows:

Section 1: That said Council hereby assents to the annexation of said territory to the City of Hoover, Alabama, and the corporate limits of the City of Hoover are hereby extended and rearranged pursuant to the provisions of Chapter 42, Article 2, Code of Alabama, 1975 (Sections 11-42-20 through 11-42-23, as amended) so as to embrace and include said territory, in addition to the territory already within its present corporate limits, within the corporate area of said City, which said territory is not within the corporate limits or municipal boundaries of another municipality and does not lie at any point more than one-half the distance between the present corporate limits and the corporate limits of any other municipality. Said property is described in Exhibit A attached hereto and made a part hereof.

Section 2: The City Clerk shall file a certified copy of this ordinance containing an accurate description of said annexed territory with the Probate Judge of Shelby County, Alabama, and also cause a copy of this ordinance to be published in a newspaper of general circulation in the City of Hoover.

Commence at the intersection of the centerline of the Cahaba River and the east line of the southwest one-quarter of Section 4, Township 20 South, Range 3 West; thence run north along the east line of said quarter section line to a point that is 43.75 feet northwesterly of and perendicular to the center line of the Cahaba River, said point being the point of beginning; from the point of beginning thus obtained continue north elong the east line of the southwest one-quarter of Section 4, Township 20 South, Range 3 West to a point that is 87.50 feet northwesterly of and perpendicular to the centerline of the Cahaba River; thence run in a southwesterly direction, parallel to and 87.50 feet northwesterly of the centerline of the Cahaba River to its intersection with a line 87.50 feet north of the south line of Section 4, Township 20 South, Range 3 West; thence run westerly, parallel to and 87.50 feet northerly of the south line of said Section 4 to its intersection with the west line of Section 4, Township 20 South, Range 3 West; thence run south along the west line of said Section 4 to a point that is 43.75 feet north of the south line of said Section 4; thence run east parallel to and 43.75 feet northerly of the south line of said Section 4 to its intersection with a line 43.75 feet perpendicular to and parallel with the centerline of the Cahaba River; thence run in a northeasterly direction along a line parallel with and 43.75 feet northwesterly of the centerline of the Cahaba River to the point of beginning.
