Part of the NW 1/4 of Section 1, Township 21, Range 5 West, Shelby County, Alabama, being more particularly described as follows: Begin at the northeast corner of the SW 1/4 of NW 1/4 of said Section 1, and run in an easterly direction and along the North boundary line of the SE 1/4 of the NW 1/4 a distance of 495.0 feet to the point of beginning; thence turn left an angle of 30 degrees 45 minutes in a northerly direction a distance of 330.90 feet; thence turn right an angle of 90 degrees 45 minutes 45 seconds in an easterly direction a distance of 660.0 feet; thence turn right an angle of 89 degrees 14 minutes 15 seconds in a northerly direction a distance of 330.0 feet to the point of beginning.
