The undersigned, acting as incorporator, of a corporation under the Alabama Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

Article I

The name of the corporation shall be "R & R Word Processing Service Inc."

Article II

The period for the duration of the Corporation shall be perpetual.

Article III

034 276 The purpose or purposes for which this corporation is organized are to conduct and carry on a word processing service, and to transact any or all lawful business for which a corporation may be incorporated under the the Alabama Business Corporation Act.

Article IV

BOOK The aggregate number of shares of stock which the corporation shall have authority to issue shall be five thousand (5000) shares of common stock with a par value of One Dollar (\$1.00) per share. The corporation shall begin business with the issuance of one thousand (1000) shares. All or any part of said capital stock may be payable either in cash, property, labor or services at a just valuation to be fixed by the Board of Directors, and the judgement of such Directors as to the value shall, in the absence of fraud, be conclusive upon the stockholders and parties dealing with the corporation. The capital stock may be issued and paid for at such time or terms and conditions as the Directors may determine and the amount of capital stock increased or decreased in the manner provided by law; provided, however, that the stock of the corporation shall be non-assessable.

Article V

The location and mailing address of the Corporation's initial registered office is 203 Inverness Lane, Birmingham, Alabama 35243, and the name of its initial registered agent at such address is Rhonda Joyner.
