ARTICLES OF INCORPORATION OF ALABAMA FOUNDATION FOR ONCOLOGY

The undersigned, acting as incorporators of a nonprofit corporation under the Alabama Nonprofit Corporation Act, Code of Alabama 1975 §§ 10-3A-1 et seq. (the "Act"), adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation shall be Alabama Foundation for Oncology.

SECOND: The period of its duration is perpetual.

THIRD: This corporation is not organized for profit and the purpose for which the corporation is organized and the objects to be carried on and promoted by it are as follows:

- (a) To fund research and treatment for cancer patients who cannot reasonably afford such care;
- (b) To promote a better understanding and awareness of cancer throughout the State of Alabama by educating the public on the prevention and treatment of cancer; and
- (c) To receive, hold, invest, administer, and expend gifts and other monies exclusively for the educational, charitable, and scientific purposes described above, so as to qualify as a tax-exempt organization under § 501(c) of the Internal Revenue Code of 1954 and its regulations as amended.

The corporation shall not engage in any activities or make any expenditures not permitted by an organization exempt under § 501(c)(3) of the Internal Revenue Code of 1986 and its regulations as amended.

FOURTH: The corporation shall have all the common law and statutory powers of a nonprofit corporation which are not in conflict with the terms of these Articles, as they from time to time may be amended.

FIFTH: The members of the corporation shall consist of any physician, health care professional, or other person involved in health care, who is approved by the Board of Directors. No member may receive benefits from the corporation other than participation in its educational programs on the same basis as any non-member.

SIXTH: No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof.

SEVENTH: In the event of dissolution of the corporation, the assets of the corporation shall be distributed exclusively to charitable, religious or educational organizations, which organizations would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code of 1954 and its regulations as they now exist or they may hereafter be amended.

EIGHTH: The initial registered agent for Alabama Foundation for Oncology is Sheila Owens, who is located at

Directors of the corporation shall be elected at the annual meeting of the members in the manner determined by the By-Laws. 
