VERIFIED STATEMENT OF LIEN

Brown Lumber & Building Supply, Inc., an Alabama corporation, files this statement of lien in writing, verified by the oath of its Secretary, A. B. Brown, III, who has personal knowledge of the facts herein set forth.

That the said Brown Lumber & Building Supply, Inc., a corporation, claims a lien upon the following property, situated in Shelby County, Alabama, and described to-wit:

Begin at the N.W. corner of the SW 1/4 of the NE 1/4 of Section 11, Township 24 North, Range 13 East and run southerly along the West side of the said quarter-quarter for 764.17 feet; thence turn an angle of 117 deg. 07 minutes to the left and run 104.87 feet, then turn an angle of 26 deg. 17 min. 30 sec. to the left and run 341.6 feet to the point of beginning. Then turn an angle of 2 deg. 30 min. to the right and run 240.43 feet, then turn an angle of 86 deg. 35 min. to the right and run 182.00 ft., then turn an angle of 93 deg. 21 min. to the right and run 254.32 ft., then turn an angle of 91 deg. 01 min. 30 sec. to the right and run 182.00 feet back to the point of beginning. The above described parcel contains 1.03 acres.

This lien is claimed, separately and severally, as to both the buildings and improvements thereon, and the said land.

That said lien is claimed to secure an indebtedness of \$4,582.71 with interest, from to-wit the 27th day of June, 1987, for materials furnished to Michael Howard Crawford and wife, Florence Crawford, the owners of said property, and their contractor, W.
