TIMBER DEED

THIS AGREEMENT entered into this 5th day of October, 1987
by and between GULF STATES PAPER CORPORATION of Tuscaloosa County,
Alabama, hereinafter referred to as Owner, and UNION CAMP
CORPORATION, a corporation of Virginia, authorized to do business in
Alabama, hereinafter referred to as Union Camp.

W I T N E S S E T H:

By Timber Contract of even date herewith between Owner and Union
Camp, Owner, for the consideration and the performance of the
covenants, all as recited in said Contract, has agreed to sell to
Union Camp, and Union Camp has agreed to buy all of the following
described property, rights and privileges:

- A. All pine trees measuring six inches and larger
in diameter outside bark six inches above the ground.
- B. All hardwood trees measuring eight inches and
larger in diameter outside bark six inches above
the ground.

The above described trees and timber are standing, growing, or
fallen on the following described lands, to-wit:

The W $\frac{1}{2}$ of Fractional Section 19 and the SW $\frac{1}{4}$
of the SW $\frac{1}{4}$ South of L&N Railroad right-of-way
in Section 18; all in Township 22 South, Range
1 West, being 269 acres, more or less, as
shown on the map labeled "Exhibit A" attached
hereto and made a part hereof.

And, subject to the provisions of said Contract, cut and remove
from the above-described lands all and singular of the said trees and
timber.

The term of said contract is for a period of twelve (12) months
from the date hereof, upon the terms and conditions as set forth in
said Contract.

Reference is hereby made to said Contract, an executed duplicate
of which is in the possession of each of the parties hereto, for all
purposes, including the description of all the property rights and
privileges of the respective parties thereunder, as well as the
consideration thereof, and the terms and conditions of which Contract
are hereby incorporated by reference.
