Shelton, to subordinate the mortgages above recited to the new mortgage to First Alabama Bank - Shelby County.

NOW THEREFORE, in consideration of One Dollar and other considerations, the said Roberta Shelton, individually and as the Executrix of the Last Will and Testament of J. T. Shelton, deceased, does hereby agree that the lien represented by the mortgages executed to J. T. Shelton and Roberta Shelton, as above recited, shall be subsequent and subordinate to the lien of the mortgage from Jack L. Shelton to First Alabama Bank - Shelby County as recorded in Mortgage Book 155, Page 240, in the Probate Office of Shelby County, Alabama.
