WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP - LAWYERS TITLE INSURANCE CORPORATION, Birmingham, Alabama

Shelby COUNTY } KNOW ALL MEN BY THESE PRESENTS,

That in consideration of One and no/100 DOLLARS

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,
Joyce M. Horton, a single person

(herein referred to as grantors) do grant, bargain, sell and convey unto
Lisa Horton Pierce and Delmore John Matzke, Jr.

(herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate situated in

Shelby County, Alabama to-wit:

Commence at the SW corner of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 14, Township 21 South, Range 2 West; thence run North along the West line of said $\frac{1}{4}$ - $\frac{1}{4}$ for 434.85 feet to the Point of beginning; thence continue last described course for 233.93 feet; thence 91 deg. 35 min. 55 seconds right run 646.91 feet; thence 88 deg. 24 min. 07 sec. right run 169.16 feet; thence 87 deg. 55 min. 34 seconds left run 156.49 feet; thence 99 deg. 39 min. right run 153.00 feet; thence 80 deg. 18 min. 10 seconds right run 140.88 feet; thence 88 degrees 28 min. 53 seconds right run 83.51 feet; thence 88 deg. 41 minutes 20 seconds left run 632.23 feet to the point of beginning. Containing 4 acres, more or less.

Also, a 20 foot easement for ingress and egress, the center line is described as follows:

Commence at the SW corner of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 14, Township 21 South, Range 2 West; thence run North along the West line of said $\frac{1}{4}$ - $\frac{1}{4}$ for 434.85 feet; thence 91 degrees 49 minutes 12 seconds right run 583.00 feet; thence 88 degrees 41 minutes 20 seconds right run 83.51 feet; thence 88 degrees 28 minutes 53 seconds left run 190.11 feet; thence 80 degrees 18 minutes 10 seconds left run 10.14 feet to the point of beginning; thence 80 degrees 21 minutes right run 195.00 feet to the Westerly R/W of Shelby County Highway 313 and the point of ending.

This is a deed of correction to correct the erroneous description in previously executed deed.

TO HAVE AND TO HOLD Unto the said GRANTEES as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEES, their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all persons.
