STATUTORY WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS:

the receipt of which is hereby acknowledged, has by these presents
granted, bargained, and sold to the Grantee, her heirs, and
assigns forever, the following described land:

to the Map and Survey of Jewell Heights, being a sub-division
of th SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 9, Township 22, Range 2 West,

simple forever.

AND THE GRANTOR DOES HEREBY COVENANT with the Grantee,
