CORPORATION FORM WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that in consideration of Four Thousand Nine Hundred Seventy and 68/100 (\$4,970.68) Dollars and other good and valuable consideration to the undersigned GRANTOR, The People's Bank of Alabama, an Alabama banking corporation, (herein referred to as "GRANTOR") in hand paid by the GRANTEE herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto Lay Lake Farms, Inc. (herein referred to as "GRANTEE"), the following described real estate, situated in Shelby County, Alabama, to-wit:

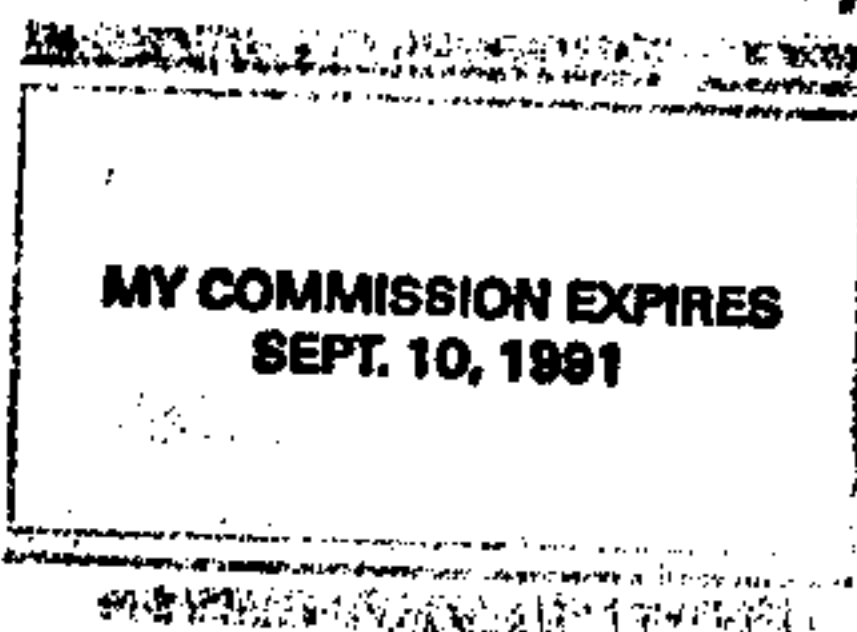
