

AGREEMENT

THIS AGREEMENT, made this 6th day of November, 1987, between EDMOND RALPH DENABURG and DAVID TODD DENABURG and BEN L. ZARZAUR, as Trustee, do hereby enter into this agreement as follows:

(1.) Edmond Ralph Denaburg and David Todd Denaburg, the undersigned, are beneficiaries of that certain Trust Agreement dated November 23, 1977, wherein Charles L. Denaburg was grantor and Ben L. Zarzaur is Trustee, which Trust Agreement is recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Book 23, Page 241, etc. Pursuant to the terms of said Trust, it terminates upon the attainment of the age of twenty-one (21) years of David Todd Denaburg. Said trust is due to terminate on the ninth day of November, 1987.

(2.) The undersigned, Edmond Ralph Denaburg and David Todd Denaburg agree and direct that said Trust Agreement dated November 23, 1977 shall not terminate, and that same shall be hereby continued irrevocably upon the same terms and conditions as stated therein until the said David Todd Denaburg attains the age of twenty-six (26) years, at which time said Trust shall terminate. We further direct that the Trustee of said Trust shall not distribute to us our distributable shares of the assets of said Trust dated November 23, 1987, that the assets of said shares continue in Trust as aforesaid, and that the said Ben L. Zarzaur continue to act as Trustee of said Trust, with the same powers and duties.

(3.) The Trustee is hereby authorized to continue to commingle our separate share interests and to invest and reinvest the Trust assets in joint or commingled assets and to continue to hold the assets now constituting said Trust Agreement according to the terms
