MINUTES OF PASSAGE OF RESOLUTION
OF PERMANENT OPERATION

The following Resolution of Permanent Operation, as follows:

WHEREAS, Shelby County Highway, or that portion thereof as described in the vacation of public road, attached hereto as Exhibit "A", and made part and parcel hereof as fully as if set out herein, has heretofore been dedicated as a public road, and

WHEREAS, said road or portion thereof described on Exhibit "A", attached hereto, is not located within the limits of any municipality; and

WHEREAS, the sole owner of the land abutting said road or portion thereof which is sought to be vacated has executed the written instrument declaring said road or portion thereof described on Exhibit "A", attached hereto, to be vacated; and

WHEREAS, convenient and reasonable means of ingress and egress to and from their property is afforded to all other property owners owning property in the tract of land embraced; and

WHEREAS, it is now desirable and expedient for Shelby County Commission, being the Commission of the County in which such road is located, to join in and assent to the vacation of said road, or portion thereof described in Exhibit "A".

NOW, THEREFORE, be it resolved by the Shelby County Commission that the Shelby County Commission does hereby assent to the vacation of said portion of said road and

that said portion of road thereof encompassed within the bounds thereof as shown in said Exhibit "A", attached hereto, and made part and parcel hereof as fully as if set out herein, be, and the same is hereby dedicated by the Shelby County Commission to be vacated as a public road and all rights of the public and all other persons, firms or corporations in and to said road or portion thereof, described on said Exhibit "A" are hereby divested:

The above said Resolution was introduced by John Gary Ray, County Engineer, at the regular meeting of the Shelby County Commission held in Columbiana, Alabama, on the 14th day of December, 1987, and it was moved by Commissioner John Ames, and seconded by Commissioner Steve Chambers, that all rules governing the Shelby County Commission which might, unless suspended, prevent the passage and adoption of said resolution at this meeting, be and the same are hereby suspended for the purpose of permitting said resolution to be finally passed and adopted at this meeting.

The Chairman signed said Resolution in approval thereof.
