NOTICE OF LIS PENDENS

YOU ARE HEREBY NOTIFIED that on the 16th day of December, 1987, a lawsuit was commenced in the Circuit Court of Shelby County, Alabama, being Civil Action No. CV-87-603, wherein the parties Plaintiff and Defendants are as stated above and whereby the Plaintiff seeks to foreclose a statutory materialman's lien against the following described real estate:

Begin at the N.W. corner of the SW 1/4 of the NE 1/4 of Section 11, Township 24 North, Range 13 East and run Southerly along the West side of the said quarter-quarter for 764.17 feet; thence turn an angle of 117 deg. 07 minutes to the left and run 104.87 feet, then turn an angle of 26 deg. 17 min. 30 sec. to the left and run 341.6 feet to the point of beginning. Then turn an angle of 2 deg. 30 min. to the right and run 240.43 feet, then turn an angle of 86 deg. 35 min. to the right and run 182.00 ft., then turn an angle of 93 deg. 21 min. to the right and run 254.32 ft., then turn an angle of 91 deg. 01 min. 30 sec. to the right and run 182.00 feet back to the point of beginning. The above described parcel contains 1.03 acres and the residence and improvements constructed thereon, all of said property being situated in Shelby County, Alabama.

Willie Robinson is a carpenter and building contractor and Michael Howard Crawford and wife, Florence Crawford are owners or proprietors of said property. The hereinabove described property is situated in Shelby County, Alabama.
