Plaintiff's Motion to Enforce Settlement Agreement and to Enter Judgment was heard before the undersigned on Friday, November 13, 1987. The Court has carefully considered Plaintiff's motion and argument of counsel, along with the exhibits to Plaintiff's motion. These exhibits include correspondence from Attorney Mark McKnight to Attorney David Marsh dated May 21, 1987 and copies of medical bills incurred by Frank Coshatt prior to his death.

Based on all the evidence in this case, the Court finds that Plaintiff's Motion to Enforce Settlement Agreement and to Enter Judgment is due to be granted and I therefor ORDER and ADJUDGE that judgment be entered in this case in the amount of Twenty-Five Thousand Dollars (\$25,000.00) for temporary total and permanent partial benefits, plus Sixteen Thousand Eight Hundred Fifty-One Dollars (\$16,851.00) for payment of medical expenses incurred by Frank Coshatt. I further ORDER that all costs of Court incurred in this action are hereby attached to the Defendant.
