Wood, III, its Sales Manager, who has personal knowledge of the facts herein set out, files this statement in writing, verified by his oath, amending the Lien filed of Record on August 6, 1987 appearing in Book 144, page 513 in the Office of the Judge of Probate of Shelby County, Alabama.

Sherman Ready Mix Concrete, a corporation, claims a lien upon the following property situated in Shelby County, Alabama, more particularly described as follows, to-wit:
