That in consideration of One Hundred Seven Thousand Sixty Three and no/100 (\$107,063.00) DOLLARS

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,
Cecil Riggins and Harold Connell d/b/a C & R Construction

(herein referred to as grantors) do grant, bargain, sell and convey unto
Michael D. Smith and wife, Renee D. Smith

(herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in _____

Shelby County, Alabama to-wit:

A parcel of land situated in the South 1/2 of the NE 1/4 of Section 16, Township 21 South, Range 3 West, described as follows: Commence at the Northeast corner of the South 1/2 of the NE 1/4 of Section 16 and go South 89 deg. 3 min. 32 sec. West along the North boundary of said South 1/2 of the NE 1/4 for 1347.11 feet to the point of beginning; thence continue South 89 deg. 33 min. 32 sec. West for 216.00 feet; thence South 3 deg. 15 min. 17 sec. West for 636.81 feet to a point on a curve on the North boundary of Big Oak Drive, said curve having a central angle of 3 deg. 56 min. 27 sec. and a radius of 2834.79 feet; thence Easterly along said curve 194.98 feet; thence North 5 deg. 05 min. 00 sec. East for 647.19 feet to the point of beginning; being situated in Shelby County, Alabama.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEES, their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all persons.
