1. The name of the corporation is Detail 1, Inc.

2. The period of its duration is perpetual.

3. The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Alabama Business Corporation Act, including, but not limited to owning, managing, developing, leasing, selling and operating automotive sales, clean-up, and other automotive improvements.

4. The aggregate number of shares of capital stock which the corporation shall have authority to issue is 200 shares of common stock, par value \$1.00 per share.

5. The location and mailing address of the initial registered office of the corporation are

8. No shareholder shall have a pre-emptive right to purchase shares of any class of capital stock of the corporation, including treasury shares.

9. The corporation shall have the right to purchase, take, receive or otherwise acquire, hold, own, pledge and transfer or otherwise dispose of its own shares. 
