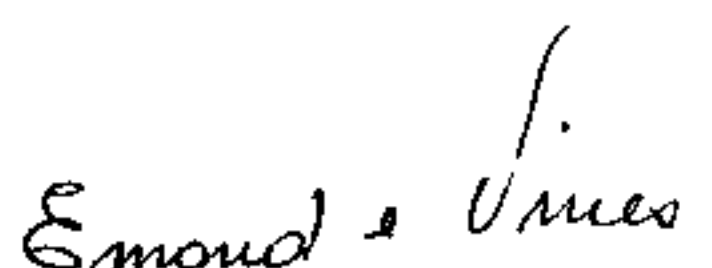

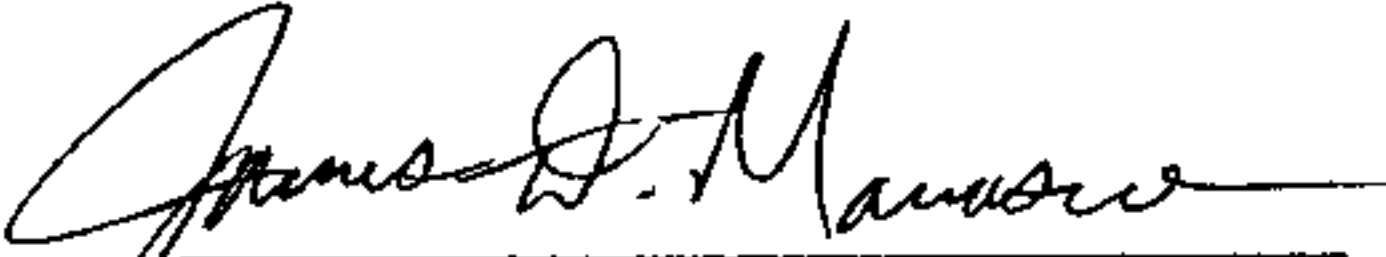
4. All remaining property and assets of the corporation have been distributed as provided by law.

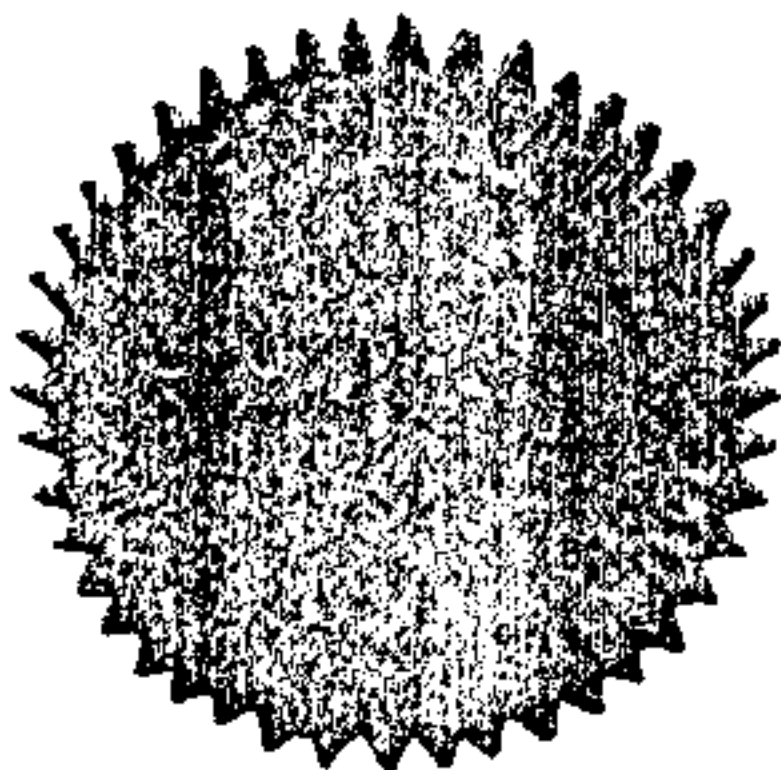
