PARTIAL RELEASE OF RECORDED LIEN

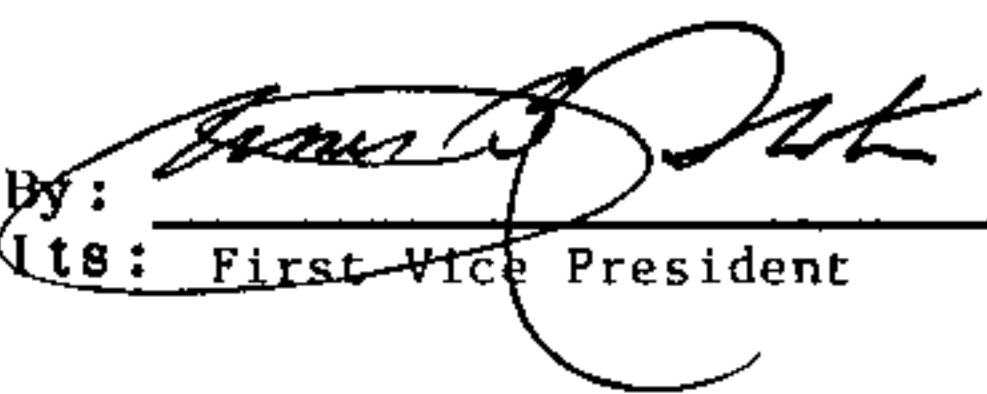

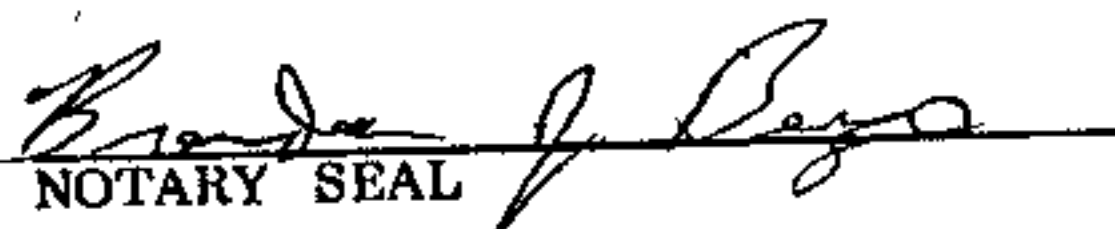
